**SUBJECT: EUROPEAN CHAMPIONSHIP FOR ASPIRANTS & JUNIORS 2010 AND JJEU
GENERAL ASSEMBLY, VIENNA – AUSTRIA, MAY 28-31 2010**

Dear Friends in sport!

JJEU Board and Ju-jitsu Federation of Austria – JJFA (JJVÖ – Jiu-Jitsu Verband Österreich) have the pleasure to invite you to 2010 European Championship for aspirants and juniors, which will be organised in Vienna from May 28 to May 31 (28th – arrival and JJEU GA, 29th and 30th – competition days and 31st – departure).

Austrian federation has invested a lot of energy and time to organise this big event on the highest level. They have observed and evaluated last JJEU/JJIF championships in order to gain as much information as possible for smooth and correct organisation. They have provided accommodation very close to sport hall – with objective to provide appropriate accommodation at reasonable price and with easy access to sport venues close by.

On May 28th afternoon JJEU General Assembly will take place. JJIF GA has changed Statutes and some other by-laws so JJEU will have to follow to harmonise its statutes and by-laws. With the first invitation proposed agenda for JJEU GA will be attached.

I would like to emphasise to all members to respect prepared deadlines! Especially if there are any suggestions for General Assembly agenda – they must be proposed to JJEU General Secretary up to February 28th (subject of agenda, short explanation and related materials to backup explanation). This is also deadline for proposals for the position of JJEU Treasurer as this position (at the moment Mr. Dario Quenza from Italy is holding it) will due to expire in 2010. Following the article of 3.2.2 of JJEU Statutes the candidacy must be sent to JJEU General Secretary (short CV and obligatory support/approval from National Federation).

JJEU Committee Directors and Commissioners are hereby invited to prepare annual activities reports and send it to JJEU General Secretary to prepare joint JJEU Board/Directors report (to be attached to the second invitation with final agenda) – should be sent to JJEU General Secretary up to March 20th.

To allow Organisation Committee of the event correct preparation, to avoid problems and to follow our Statutes and by-laws we would like to stress to all to respect the following schedule:

We would like also to remind that following article 5.5.2 of our Statutes each member should pay annual membership fee to the end of February to allow participating at JJEU official events. Details for payments were sent to all members with e-mail letter from JJEU General Secretary on February 5th 2010 (500 EUR to JJEU bank account and 500 EUR to JJIF bank account). A prove of payment will be issued to national member by JJEU Treasurer.

One of the items on agenda will be changes of JJEU Statutes, to harmonise it with JJIF Statutes – proposals and suggestion from members must be sent to JJEU General Secretary at least one month before the General Assembly (that would be April 28th). We would like to suggest trying to send it up to March 30th. That way we would be able to include it in the second invitation materials.
